

2018 Utah Statewide Summary Report of the Post High School Outcomes Survey of 2016-17 Exiters with Disabilities

The following is based on a total count of 1601 exiters.

EXECUTIVE SUMMARY

The Utah Statewide Post High School Outcomes Survey of Exiters with Disabilities is summarized below. This summary report focuses on youth with disabilities who exited high school with a diploma, certificate of attendance, reached maximum age of eligibility, or dropped-out of school during the 2016-17 school year and are now out of high school one year. The results of the survey are organized around three areas of interest. The outcomes for youth with disabilities for each area are summarized below.

POST SECONDARY EDUCATION AND TRAINING

Includes any type of formal education or training program after high school

41% (652) of respondents are or have participated in a postsecondary education or training program within the year since leaving high school. Some youth do more than one thing, as represented by the duplicated participation counts below.

20% (324) of respondents completed at least one term of the following types of higher education programs within the year of leaving high school:

- 8% (122) 2-year College or Community College
- 8% (135) 4-year College or University.
- 5% (86) 2-year Technical College.

19% (308) of respondents completed at least one term at the following types of higher education programs within the year of leaving high school

- 6% (99) High school completion program, including a GED program.
- 4% (72) Vocational/Technical school
- 4% (72) Job training or Short-term education or employment training program.
- 6% (98) Church Mission or another Humanitarian Program
- 0% (6) Any other type of formal education or program since leaving high school

EMPLOYMENT

Assesses competitive and other employment, job setting, wages and benefits

61% (969) of respondents are or have been competitively employed within the year of leaving high school. This means they are working for pay at or above minimum wage in a setting with others who are nondisabled for a period of 20 hours per week for at least 90 days.

Of the 81% (1299) of respondents who are currently employed or have been employed within the year of leaving high school:

- 74% (1187) of respondents have been employed for 90 days
- 7% (112) of respondents have worked within the year since leaving high school, but for less than 90 days
- 18% (286) of respondents have not been employed since leaving high school
- 86% (1123) work for a company or service in the community
- 2% (22) are in the military
- 4% (49) work in a supported employment setting
- 5% (70) are self-employed or working in a family business
- 2% (29) work in a sheltered employment or institutional setting

- 84% (1091) work 20 or more hours per week
- 13% (174) work less than 20 hours per week

- 1% (15) earn less than minimum wage
- 10% (133) earn minimum wage
- 83% (1077) earn more than minimum wage

- 24% (316) of employed respondents receive benefits at their place of employment

INDEPENDENT LIVING

Assesses residential arrangements and general community participation

- 66% (1053) of respondents continue to live at home with their parents.
- 30% (481) of respondents live independently.

Indicator 14 Unduplicated Data Components

- 20% (324)** **HIGHER EDUCATION** - Completion of at least one term at a 2-yr College or Technical College or 4-yr College or University regardless of participation in Employment or other Postsecondary Education or Training.
- 49% (777)** **COMPETITIVELY EMPLOYED** - 90 consecutive or cumulative days in a community setting, working 20 hours or more per week and earning minimum wage or greater AND not counted in Higher Education and regardless of engagement in other Postsecondary Education or Training or Other Employment.
- 7% (113)** **OTHER POSTSECONDARY** - Completion of at least one term at any other short-term education or training program, humanitarian program or high school completion program AND not counted in Higher Education OR Competitive Employment and regardless of engagement in Other Employment.
- 8% (136)** **OTHER EMPLOYMENT** - 90 consecutive or cumulative days of employment in any setting AND not counted in Higher Education OR Competitive Employment OR Postsecondary Education or Training Program.
- 16% (251)** **Not Meeting Participation Criteria** - Respondents who have: (a) not completed at least one term in higher education program or other postsecondary education or training; (b) never been competitively or otherwise employed; (c) have been underemployed; (d) have missing data elements.

Indicator 14 Reporting Components

- 20% (324)** **MEASURE A** which includes higher education respondents.
- 69% (1101)** **MEASURE B** which includes higher education and competitively employed respondents.
- 84% (1350)** **MEASURE C** which includes higher education, competitively employed, other postsecondary education, and other employed respondents.
